He is a patent agent, registered to practice before the Indian Patent Office since 2004. He is also a Certified Patent Valuation Analyst from the Business Development Academy, USA. He specializes in US patent prosecution and IP strategies for technology startup companies, and creating and managing their global patent portfolios. Previous to founding Metayage, he was the first hire at, and he established India Operations for a US patent law firm RAPC (which was recently recognized as the largest trademark law firm in the world) where he worked for Silicon Valley based startup companies and VCs, as well as MNC companies with R&D centers in Bangalore. He has been trained by leading US patent attorneys on US patent prosecution and patent due diligence for Venture Capital Investment. Previous to RAPC, he managed end to end patent back office support for law firms in the US and UK at a Bangalore based LPO, Manthan Legal (which has recently been acquired by Exigent group limited), where he executed various strategic IP projects spanning Patent Landscape, Due diligence for Patent Litigation, Licensing and Acquisition (including drafting a patent license agreement along with a team of lawyers), and US patent prosecution support. Before joining Manthan, he worked at the Industrial Research and Consultancy Center (IRCC) of IIT Bombay. He completed his Masters Degree in Chemistry (5 year Integrated) from IIT Bombay, and holds a Diploma in Intellectual Property Rights and TRIPS from IES, Bombay.
