TERMS

- PAYMENT TERMS

Only Venture Center staff will have access to these analytical instruments and shall carry out the necessary analytical services as per SOP and EHS guidelines laid down by Venture Center. However the applicant will have access to the computer with the relevant data analysis software (up to 1 hr max). Venture Center shall collect samples for analysis and submit the results of analysis as per the schedule agreed upon while collecting the sample. For these services consumables cost is part of the charges applicable.
 - Other equipments that are part of analytical services like GC, HPLC, Flame Spectrometer-UV, Flame Spectrometer-NIR, STS Micro Spectrometer-UV, STS Micro Spectrometer-NIR, Spectrofluorometer can be used through two options.
 - Option A: The above instruments can be used by applicants having prior experience using these equipments. Venture Center lab staff will give the initial introduction for usage, data retrieval software as well as precautions to be observed during use. Applicant also has to qualify the Venture Center Safety test before using these equipments. Applicant shall use the equipment as per SOP and EHS guidelines laid down by the Venture Center.
 - Option B: Venture center staff can analyze the samples for clients. However the applicant will have access to the computer with the relevant data analysis software (up to 1 hr max). Venture Center shall

- For use of these equipments, consumables cost is **not** part of the charges applicable clients must
 use their own consumables. In some cases, for sample preparation, applicant may need to avail
 additional services (e.g. Hot lab package, work bench etc). Cost of these will be charged separately.
- Flow Cytometry, Confocal Microscopy & Mechanical Testing services are offered as Venture Center Staff Facilitated Service.

- Analytical services will be available only during the official working hours of Venture Center.
