STUDIO/RECORDING ROOM is on the first floor of the 200 NIP Networking Block on the Venture Center Campus.

- High end camera to do the video recording

- Workstation: PC with Audacity (audio) and DaVinci Resolve (video editing).
- A 55 inch TV Screen: For display, monitoring, or multipurpose use.
- Furniture: Standard seating and podcast table.
- Ideal for podcasts, interviews, video recordings, and online meetings
- Seating capacity: Up to 4 persons (maximum occupancy – 4 persons)
- Furniture: 1 table + 3 chairs
- Basic Utilities including electricity are included in the price.
- Generator back-up for lights and power plugs
- Internet/wi-fi can be made available at an additional charge
- Access to an aerial view of the campus with a lot of green cover, NCL Innovation Park's serene and elegant environment, free parking, campus amenities

- Payment made thereof shall be **non-refundable**
